## Section 4 First Aid Measures

**Eyes:** Flush eyes with running water for at least 15 minutes. If redness, blurred vision or irritation persists, transport to nearest medical facility for additional treatment.

Have appropriate fire extinguishers and spill clean-up equipment in or near storage area.

**Work/Hygienic Practices:** Wash with soap and water before eating, drinking, smoking, applying cosmetics, or using toilet. Launder contaminated clothing before reuse. Properly dispose of contaminated leather articles such as shoes or belts that cannot be decontaminated.
